# RHO KAPPA

## Florida Council for the Social Studies Student Honor Society

### Overview

This is an honor society for the recognition of achievement and excellence in the discipline of social studies at the high school level. This society is open to juniors and seniors who meet the entrance criteria. Although the statewide name of the organization is RHO KAPPA, individual chapters may be established by school districts and/or schools, which may be named after noteworthy contributors in the field of social studies. (See affiliation agreement for details.) Our name, RHO KAPPA, is taken from two words of semitic origin. RHO is derived from “resh” meaning “head” and KAPPA is derived from “kapf” which means “palm of the hand.” Both these terms symbolize our firm belief that knowledge, without service, is useless.

### Criteria

Juniors must have 2.5 credits in academic social studies courses with a minimum 3.5 unweighted grade point average in those classes. For juniors to maintain membership they must continue to pursue academic social studies courses and work toward a minimum of 4 credits in these courses while maintaining the 3.5 unweighted grade point average. Students must exhibit qualities of leadership, service and citizenship in either their school or in a community group / organization. The signatures of two adult sponsors on the student application will serve as testimony to the student’s having met the leadership, service and citizenship criteria.

Seniors must have a minimum of 3.5 credits in academic social studies courses and currently be enrolled in the one course; or they may have 4 credits in social studies coursework upon graduation. All students must maintain a minimum 3.5 unweighted grade point average.

### Membership

All high school students in Florida who meet the criteria stated above and whose schools are affiliated with the state chapter of RHO KAPPA sponsored by FCSS are eligible for membership. The annual membership fee for affiliated high schools is \$35.

### Honorary Memorabilia

Individual chapters are encouraged to provide the following memorabilia to their participating students. All inductees should receive a certificate of membership in RHO KAPPA. As part of the annual affiliation fee of \$35, participating chapters will receive access to the awards certificates online that schools may then fill in for signature and students’ names. There are also medallions and membership cards available for schools to purchase according to the rates below. **All proceeds will be used for the establishment of an FCSS student recognition / award program.**

# **The RHO KAPPA Social Studies Honor Society Constitution**

**Sponsored by the  
Florida Council for the Social Studies  
Ratified October 14, 2000**

## **Article 1. Purpose**

Section 1. The purpose of this organization is to promote scholarship and to recognize academic excellence in social studies among high school students.

## **Article 2. Name**

Section 1. The name of this chapter shall be the \_\_\_\_\_ High School \_\_\_\_\_ Chapter of RHO KAPPA.

## **Article 3. Sponsor**

Section 1. The organization shall at all time have a designated faculty sponsor.

## **Article 4. Membership**

Section 1. Each High School shall be affiliated as a designated chapter within the Florida Council for the Social Studies RHO KAPPA Student Honor Society.

Section 2. Active members are High school students who have completed five semesters of college preparatory social studies and in addition are prepared to complete eight semesters. The minimum grade point average for these courses is an unweighted 3.50 G.P.A. Individual chapters may increase but not decrease this requirement.

Section 3. Members shall demonstrate ability to work with others and to conduct independent research, and shall possess qualities of industry, initiative, and reliability.

Section 4. Members shall contribute service to the school at the direction of the principal.

Section 5. Candidates for membership shall have completed at least one semester in \_\_\_\_\_ High School.

Section 6. Selection of members shall be made by the Admissions Committee (see Article 7) composed of the sponsor and the officers of the chapter.

## Article 5. Meetings

- Section 1. The chapter shall meet a minimum of once a semester at a specified time that is agreeable to both the Admissions Committee and the school administration.
- Section 2. Meetings are open to all interested persons.
- Section 3. At regular meetings, the program shall consist of a discussion of pertinent chapter business.
- Section 4. In all matters of conduct not specifically addressed in this constitution, the chapter shall be guided by Robert's Rules of Order.

## Article 6. Officers

- Section 1. The chapter officers shall be the following: president, vice-president, secretary, treasurer, and the historian.
- Section 2. Election of officers shall take place during the final regular spring meeting.
- Section 3. The term of office is one school year.
- Section 4. An officer may not hold the same office for more than one year.

## Article 7. Duties of Officers

- Section 1. The President shall be the chief executive officer of the chapter. He or she shall preside at all business sessions, and it shall be the duty of the President to direct the activities of the organization.
- Section 2. The Vice-President shall perform the duties of the President at times when the President is absent, and shall also serve as the Program Chairman.
- Section 3. The Secretary shall keep an accurate record of all proceedings and certify the names of all new members.
- Section 4. The Treasurer shall handle all money belonging to the chapter and shall maintain an accurate record of financial transactions.
- Section 5. The Historian(s) shall keep an ongoing chronicle of this society's activities.
- Section 6. The officers shall serve with the sponsors as the Admissions Committee and Executive Committee, having authority to transact all routine business and to select new members of the chapter.

## Article 8. Awards

- Section 1. (Optional) Senior members in good standing will be awarded medallions at the Senior Awards Night and shall be worn on the night of graduation.

## Article 9. Constitution

- Section 1. Concurrence of two-thirds of the active members shall be required to accept this constitution.
- Section 2. Any amendments to this constitution must be presented by an active member in the form of a motion during a business meeting. It must then be placed on the table until the following meeting, at which time it will become effective provided it is passed by two-thirds majority of the active members.
- Section 3. The local chapter constitution must not violate a stipulation of the state constitution.
- Section 4. By-laws may be adopted to amplify the constitution and to take care of details.

## **Suggested RHO KAPPA By-Laws**

1. Officer requirements
  - a. 15 hours of documented voluntary service
  - b. a recommendation by two teachers of the social studies department
  - c. application must be submitted two weeks prior to the election
2. Dues
  - a. Each active member must contribute \$10 in dues by June 1 of the school year
3. Meetings
  - a. The Executive Committee shall meet on the first Monday of each quarter or upon the request of the Principal or the sponsor

# RHO KAPPA INDUCTION CEREMONY

# (Sample)

(FCSS wishes to thank Ft. Myers High School - the first established RHO KAPPA CHAPTER - in Ft. Myers, FL for much of this sample ceremony)

Materials Needed: Three candles – colored white, green and gold  
Music for processional and recessional marches  
Certificates for all student inductees

1. Processional – officers lead candidates in
2. Pledge of Allegiance – Select an officer to lead
3. Welcome and Introductions – faculty sponsor or officer
4. Guest Speaker
5. Induction Ceremony

- I. Introduction by RHO KAPPA President

Candidates, you are being presented for induction in RHO KAPPA, a society whose sole purpose is to honor excellence in the Social Studies. It is an honor to be selected for membership in the organization and I congratulate each of you for attaining this distinction. Our name, RHO KAPPA, is taken from two words of semitic origin. RHO is derived from “resh” meaning “head” and KAPPA is derived from “kapf” which means “palm of the hand.” Both these terms symbolize our firm belief that knowledge, without service (a helping hand extended in friendship to others), is useless.

Each of you meets the requirements for membership, and this includes superior work in college preparatory Social Studies classes. Your work demonstrates the qualities of industry, initiative, and reliability.

The principle purpose of RHO KAPPA is to stimulate a deeper and more comprehensive understanding of all the academic disciplines comprising the social studies curriculum. Thus, on

this occasion it is appropriate to take a moment and reflect on the significance and contributions of the social studies in the development of the individual.

(First speaker approaches table and lights the white candle.)

II. First Speaker – Vice President

The white candle represents *veritas*, or truth. According to Nadine Gordimer, a South African author, “The truth isn’t always beauty, but the hunger for it is.” In Social Studies we seek the truth. The truth we seek is untarnished by prejudice or bias. It is this search that leads to greater understanding of the world and humanity’s place in it.

(Second speaker approaches table and lights the green candle from the white candle.)

III. Second speaker - Officer

The green candle stands for *scientia*, or knowledge. The great philosopher Euripides stated, “Who so neglects learning in his youth, loses the past and is dead for the future.” As a member of RHO KAPPA you have the distinction of being one who seeks knowledge in your youth and you are therefore building upon your understanding of the past in order to create a future of your own and that of the world in which we live.

(Third speaker approaches the table and lights the gold candle from the white candle.)

IV. The gold candle represents *sapientia*, or wisdom. As Justice Oliver Wendell Holmes said, “It is the province of knowledge to speak, and it is the privilege of wisdom to listen.” Wisdom is the tool we use to discern what is true and how to value that truth.

6. President (or faculty sponsor) comes to the podium to address the candidates.

. . . . to the inductees:

“You have now heard briefly the major characteristics of the RHO

KAPPA scholar. Those of you who agree that you will strive to fulfill these fundamental principles, please rise for your induction.

I, (state your name), do promise to search for truth, to utilize knowledge, and to seek wisdom through the pursuit of academic excellence in the Social Studies. I promise service to High School, for true scholars of the Social Studies lead by example.

I now declare you members of RHO KAPPA. As your name is called, please come to the stage. Our principal and staff will present each of you with a membership certificate. Our guests on the stage will also wish to congratulate you.

7. Awarding of certificates by school Principal and social studies staff.
8. Optional - RHO KAPPA Officer

Spoken to the school Principal:

An honor society has little meaning without service. Please accept our promise to serve at your request, whatever the needs for our high school.

Spoken to the audience, guests and candidates:

Thank you for joining us today to honor these students and we wish to extend an invitation to each of you to join us for a reception to immediately follow in the school commons area.

## ACKNOWLEDGEMENTS

The Florida Council for the Social Studies gratefully acknowledges the previous work done by the Social Studies Department at Fort Myers High School in Ft. Myers, Florida, in establishing the first High School Social Studies Honor Society for their students. The Constitution, By-laws, induction ceremony and nomination forms were adapted from documents used by this first chapter. The chapter was established in 1998 and named in honor of Mr. Richard Kephart, a long time social studies teacher and department chairperson at the school. The Social Studies department literally had to invent the honor society, for none existed at that time. Searches at NCSS and NCHE revealed no such programs for honoring high school students. As a result, Maureen Copeland and the social studies staff established the criteria and applied for a grant from the Lee County Schools Educational Foundation to obtain initial funding for the program. The program continues to be sponsored by the social studies department at the school and has hundreds of student members. In the spring of 2000, over 140 students met the school's very high criteria of a 3.7 weighted G.P.A. and were inducted into the society.
